- Ethics Series Partnership with the Union League Club of Chicago

- Finalized the DePaul MiniCases online store to offer short undergraduate case studies on day to day ethics issues in the workplace for an entry level or intermediate level employee. We also uniquely offer business law related questions and teacher's notes for each case. The site is currently live and we will begin a large marketing push this summer.

- Hosted a two day Ethics Across the Curricula Workshop (Basics) for 25 DePaul faculty across all disciplines to aid them in integrating ethics into their own classrooms.
