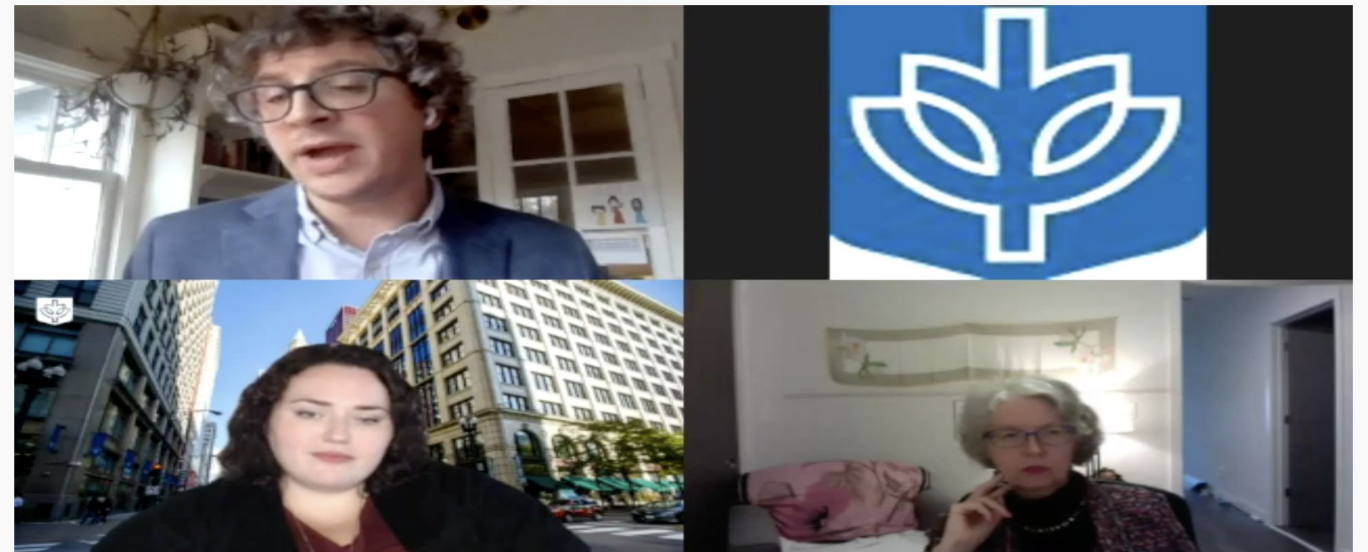

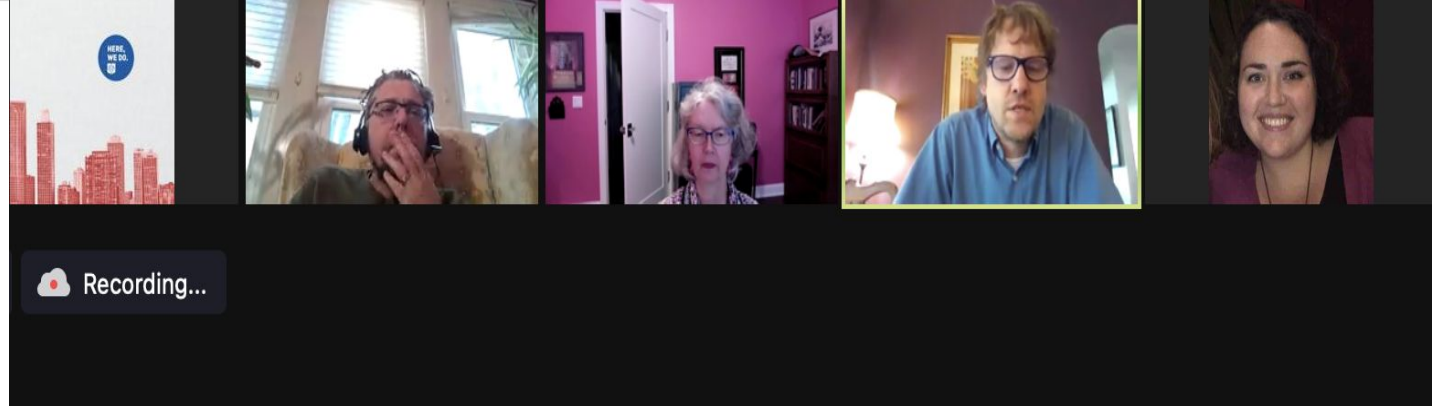

- Human responses to changing climate

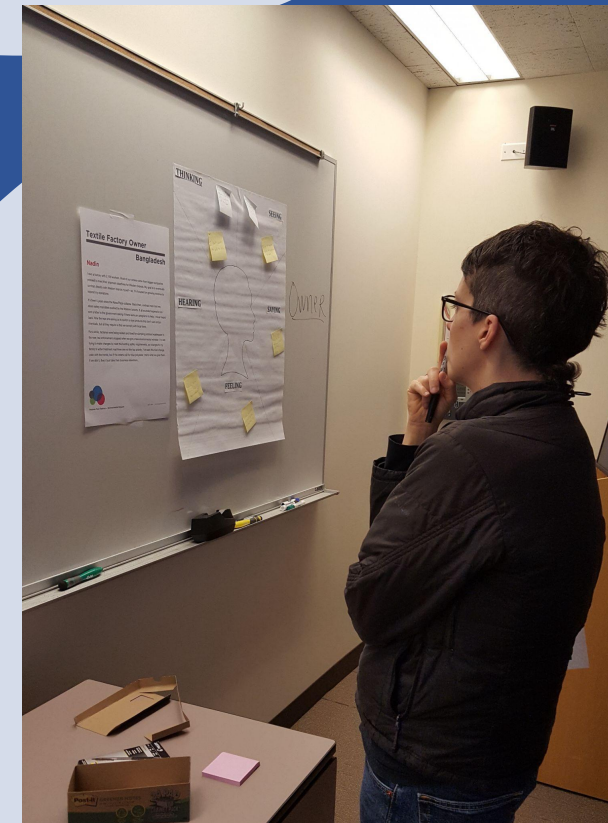
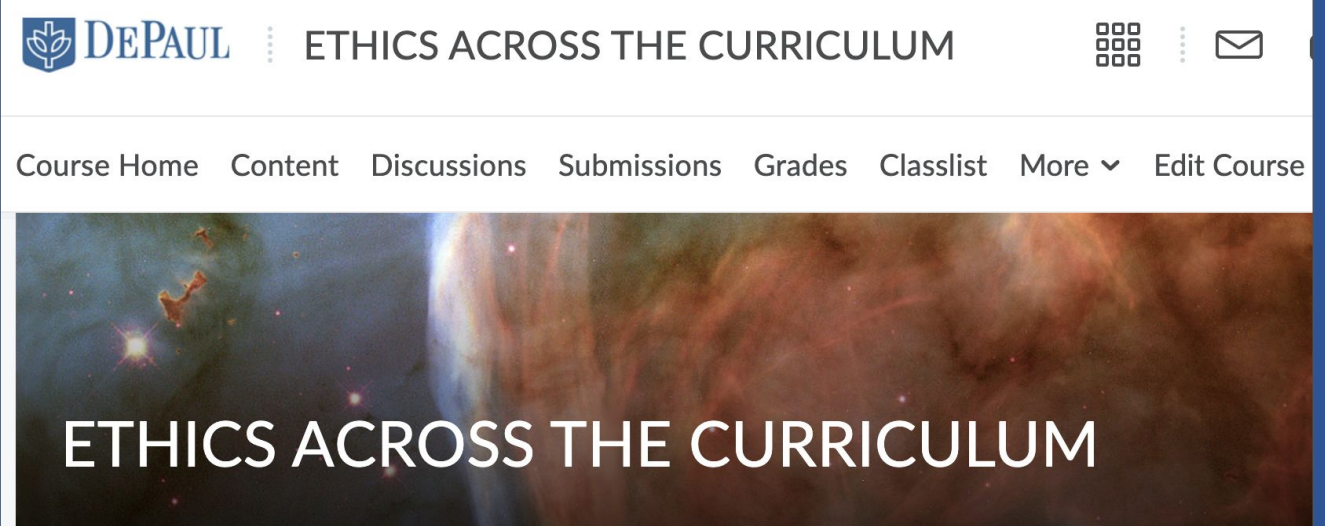
### The Big Policy Questions

# Vote DePaul Project

Hired 7 DePaul students to serve as Voter Registration Geniuses to help DePaul students register to vote and request mail in ballots

Partnered with Premiere DePaul program for Freshman Orientation to register new students

Tabled every week for a year in the DePaul Student Centers registering students

Received a grant from the Ask Every Student Initiative - \$7000

Crowdsourced funding for supplies- \$2500

Registered over 300 students to vote





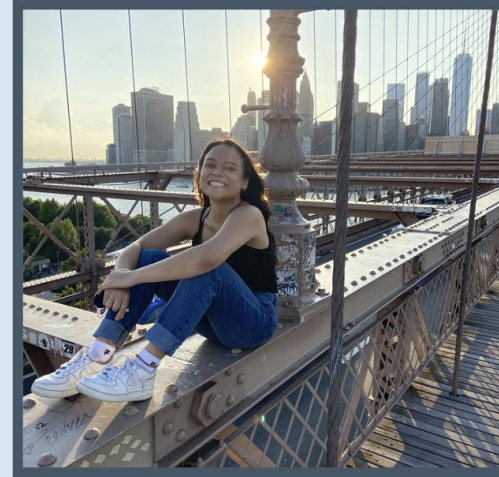
# DePaul Centers Honor Students

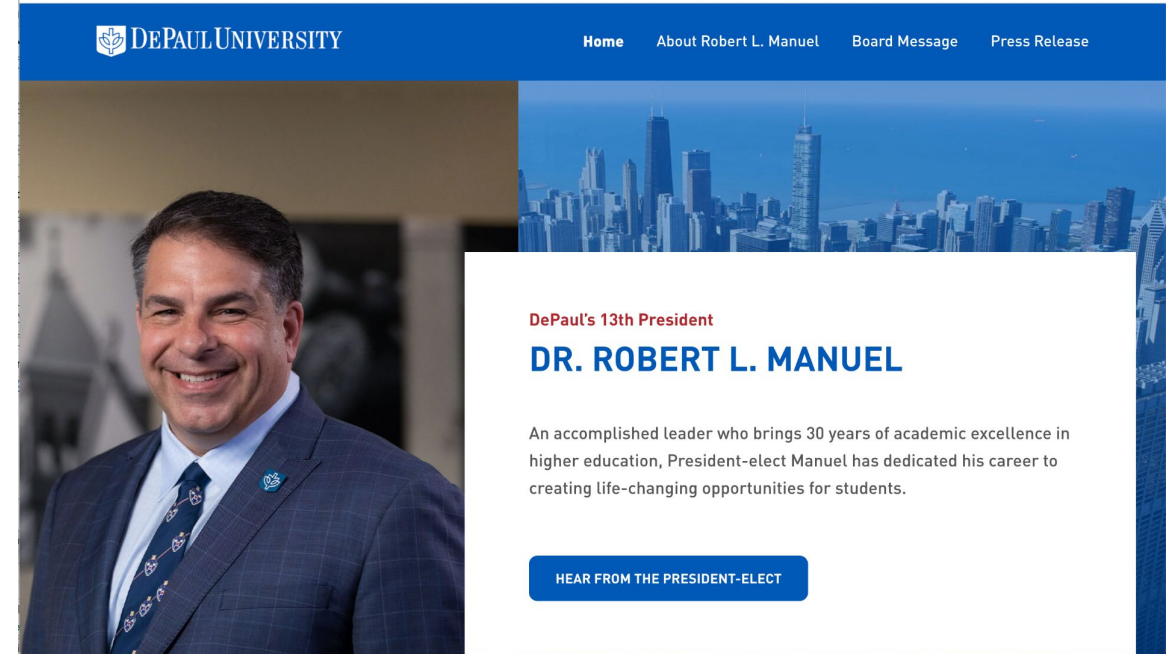




# Presidential Search Committee

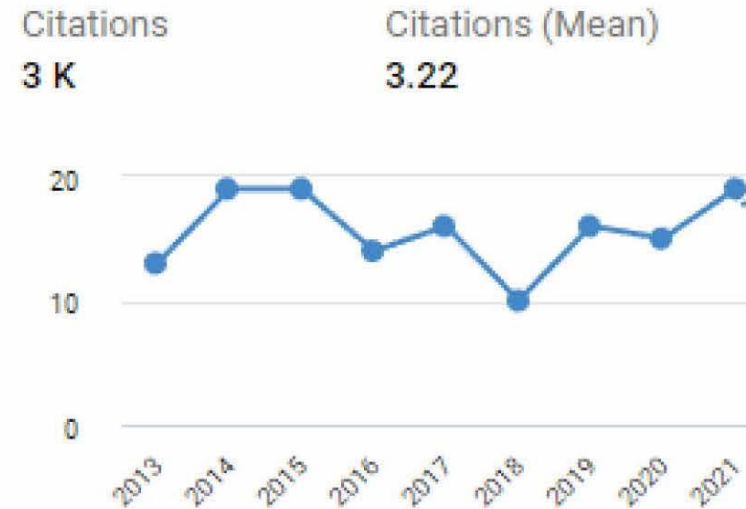


## Top Articles by Popularity (2021)
