Compete in the 17th Annual Driehaus Investment Competition

Win cash prizes | Compete for a paid, summer internship
Learn the Driehaus Growth Investment Philosophy from industry professionals

For Driehaus College of Business Students (Sophomores, Juniors, & Seniors)

The Driehaus Investment Competition is designed to help students develop practical investment research skills and prepare for careers in the investment management industry. Students are divided into one of three sector teams and charged with finding three growth stocks that can beat the market. Participants will learn the Driehaus Growth Investment Philosophy, drivers of stock performance in their respective sectors, and how to develop investment cases. Students will present their ideas to a panel of Driehaus investment professionals and DePaul finance faculty. Participants will be evaluated on individual stock returns relative to the market (50%), the strength of their investment cases (30%), and presentation skills (20%). The Competition will run during the academic year from Fall Quarter 2018 through Spring Quarter 2019, will include opportunities to meet with a range of Firm employees, and will provide cash prizes, courtesy of Driehaus Capital Management LLC:

Best Overall Performance on each Sector Team:	\$ 1,500
Sector Team with Best Relative Returns (per team member):	\$ 750
Aggregate Portfolio Exceeds the Russell 2000 Index (per participant):	\$ 100

In addition, the top five participants based on overall performance will be invited to compete for a paid, summer internship at Driehaus Capital Management.

Who is Eligible:

- Driehaus College of Business students with Sophomore, Junior, or Senior status.
- Must be enrolled at DePaul for the *full* academic year 2018-2019.
- Cumulative overall GPA of 3.0 or better.
- NOTE: No previous investment coursework or experience required, just an interest in learning about it!

How to Apply:

- Complete the Application Form.
- Attach a current resume and essay- answering the noted question.
- Deadline: **9/28**, participants will be notified by 10/5 regarding acceptance.

Guidelines:

- Approximately 25 students will be selected.
- Competitors will attend:
 - Kickoff workshop: 10/12
 - (2) Analyst training workshops: 10/26 & 1/11
 - (3) Presentation meetings: 11/9, 1/25 & 3/8
 - (1) performance update & guest speaker meeting: 12/7
 - (2) recommended performance update & guest speaker meetings: 2/22 & 4/5
 - Award ceremony and luncheon: 5/10.
